TROOP 104 COMPLETES 72-MILE TREK AT PHILMONT RANCH

Nine Scouts from Troop 104 of Scotch Plains successfully completed a 10-day, 72-mile trek at the Philmont Scout Ranch this past July. This unforgettable hiking adventure up rocky vertical trails and through grassy meadows at elevations often 9,000-10,000 feet above sea level was a life-changing experience the crew is proud to have endured.

The trip began with a two-day stay in Colorado so the scouts could acclimate to the high altitudes. While in Colorado, the troop visited the Garden of the Gods, a national Natural Landmark located in Colorado Springs. The Garden contains rocks of red and pink sandstone which were formed millions of years ago, creating a gorgeous scenic area with breathtaking views. Later, the crew went to the top of Pikes Peak, which is one of Colorado's many mountains and tops 14,000 feet. It's known for its easy accessibility, having a single road that takes roughly 2 hours to drive up.

After going white-water rafting on the Arkansas River, the troop headed to Cimarron, New Mexico where the Philmont Ranch is located.

Philmont Scout Ranch is operated by The Boy Scouts of America and is located in the Sangre de Cristo Range of the Rocky Mountains in northeastern New Mexico.

Philmont is known for its high-adventure backpacking treks and programs that include activities highlighting the history of the Old West. Although the troop had many programs, some highlights included: fly tying and fishing, and 3D archery.

The crew's biggest challenge was climbing up Mount Phillips, which is an 11,721 foot peak. It's the second highest mountain that Philmont has to offer after Baldy Mountain.

The last climb of the trek was to the top of the Tooth of Time which rises 9,003 feet above sea level. It's a mountain that has a tooth-shaped rock outcropping at the top, and it's considered to be the official icon of the Philmont Scout Ranch. During the days of wagon trains, the Tooth served as a major landmark for guides, who used it to determine the cut-off for heading to Santa Fe or the Oregon Trail. It's visibility from base camp and the incredible 360-degree view it has to offer over a large area of the ranch was perfect for ending the trek there.

Troop 104 is sponsored by All Saints Church in Scotch Plains and meets every Monday night when SPF schools are in session. Their website is http://t104.us.

EVANGEL CHURCH SERVICE FOR SERVICE 2021

When Hurricane Ida arrived with devastating floods throughout New Jersey, Evangel Church was in the midst of planning its biannual Service for Service for the weekend of October 8-10th. This is where hundreds of volunteers from the church give up a Sunday service to be of service to their surrounding communities. Service for Service, incidentally, had its inception in 2013, one year after Superstorm Sandy. Senior Pastor, Chris Morante, along with Director of Ministries, Maria Cortes, quickly realized that waiting until October was not an option, so they began to mobilize.

In addition to helping congregants who were impacted, they put out a call and began forming response teams to go directly to neighbors who needed help. They dispatched sump pumps, shop vacs, and fans and had boots on the ground where flooding was the worst. Volunteers helped people

Scotch Plains Township A grove on the site of the historical Frazee House is was dedicated on Thursday, Sept. 30 to memorialize township residents who died from complications of COVID-19.

The township has planted Kwanzam Cherry trees in memory of residents who the community has lost. The tree was selected because of its deep pink spring blooms that last for weeks, prompting the annual Cherry Blossom Festival in Washington D.C. and other events that entice people to routinely visit.

"We could think of no better place than Frazee House Park to create this lasting tribute," said Mayor Josh Losardo. "It is a passive park at the corner of Raritan and Terrill roads, home to the Scotch Plains Community Garden, a walking path and chessboard top picnic tables. We hope the tree memorial will give residents yet another reason to explore the park."



empty the saturated contents of basements and garages and even tore out ruined carpeting. Pastor Chris secured a block of rooms at a hotel in Woodbridge for those who were completely displaced and volunteers manned a 'care center' where hot meals were brought in and people could receive basic necessities. One of Evangel's partnering organizations, Convoy of Hope, sent a tractor trailer filled with cleaning supplies which were boxed and distributed to approximately 600 families. "When the world is at its worst, we believe the church should be at its best," said Pastor Chris.

Although the heart behind Service for Service has been in motion since the beginning of September, the actual event is still taking place. If anything, supporting their neighbors through the devastation of Ida has fanned into flame the desire to be of service on the weekend of

October 10th. Projects include packing 100,000 meals for Feed My Starving Children, assembling hygiene kits for Convoy of Hope, and an anti-human trafficking outreach to local motels. Besides these larger projects, they will also provide light handyman services to seniors both inside and outside of the church community.

When Pastor Chris considered Service for Service 2021, the question that came to his heart was, "Where is Evangel Church?" The answer was loud and clear - "The church is not a place, it's a people, it's not a building, it's a body." This belief is what motivates Evangel to give up meeting for a Sunday service to serve their community with Christ's love.



Anne Collart, President of the Board of Trustees, was among those welcoming advocates. "It was a gorgeous day, and the



FLINTLOCKS RUN CUB SCOUT WOOD TOOLS BADGE PROGRAM

Submitted by Dr. D. Michael Hart The Flintlocks BSA, Inc. ran the Cub Scout Wood Tools Program at the Watchung Mountain District Spring Cub Family Camporee at Boy Scout Camp Winnebago in Rockaway, NJ this spring.

Fifty-three Cub Scouts earned a Woodcraft badge by learning about how to use wood tools, safety measures, and building a small bird house. The program starts with one of the Flintlocks explaining how to use wood tools properly and important safety measures. After the Cub Scouts build their bird house, they may practice using screwdrivers and a coping saw. The parents work with the children, and the Flintlocks offer guidance.

The Camporee has many different activities, including Archery, Batting cages, BB guns, First Aid Classes, and Fishing Derby, Climbing wall, Basketball, Volleyball, a 2-mile Hike, Rockets and Catapults. The shooting sports programs have NJ State Certified Instructors. Since it is a family camporee, and since girls may now join scouts, entire families may enjoy the fun, and the scouts earn various badges. Attendance at the camporee was 150 scouts with an equal number of parents. This was one of the first big events at the scout camp since the shutdown over a year ago.

The Flintlocks BSA, Inc are a group of 27 retired scouters who volunteer every week all year round to help the scout camps of the Patriot's Path Council. They are incorporated as a separate 501c3. Facebook page is "Flintlocks". They do maintenance at the camps, build cabins, tent platforms, picnic tables, etc. In 2018 they built a STEM lab classroom for scientific related merit badges. The members also volunteer to help the scouts with various programs throughout the year. The Flintlocks purchase lumber from a lumber mill, then make the parts for the craft kits in their wood shop which are sold at the Council Scout shops. Bird houses have the bottoms attached with screws since a mother bird wants to build a new nest every year. The old nest needs to be cleaned out in the fall so a new family can start over again in the spring.

TURN AROUND, DON'T DROWN

When Tropical Storm Ida recently tore through our area, over 25 people in New Jersey died, mostly from drowning. Although some of these deaths couldn't have been prevented, others could, especially those that occurred on our roads.

According to the Centers for Disease Control and Prevention, over half of all flood-related drownings occur when a vehicle is driven into hazardous flood water. The next highest percentage of flood-related deaths is caused by walking into or near flood waters.

In their desire to get to their destinations, many people underestimate the power and force of water. When coming upon a flooded road, instead of backing up and finding an alternate route, they tell themselves that their vehicles can get through just fine, often misjudging how deep the water truly is. Many times, this leads to tragedy. Once in the middle of these flood waters, cars often stall and people find themselves stranded and in trouble.

If they're lucky, rescue crews are nearby and can pick them up before the water gets even higher or their cars are washed away by flash flooding. If they're not, and can't make it back to dry land, they often drown. Driving into flooded waters also puts first responders at risk when they have to venture into these dangerous waters to save others.

So the next time you drive up to a flooded road, turn around. Don't take the chance; don't gamble with your life and that of others. Drive to higher ground and find a safe place to wait until the water recedes and it's safe to travel once again.
